- 2) Bangladeshi heritage: Submit a copy of any one of the following: Bangladeshi Passport/ BD National ID Card / Birth or School Certificate
- 3) For foreign passport holders, provide copy of the “No Visa Required” page.
- 4) For Individual Membership: Copy of academic qualification or professional qualification certificate.
- 5) For Corporate Membership: Please submit an Audited account of the Company demonstrating that the annual turnover is over QR 1 million.
- 6) The Executive Committee reserves the right to accept or reject any application for membership without assigning any reason thereof.
- 7) Balloting within the Executive Committee shall be carried out in secret. Result of the balloting shall be communicated to the applicant, but no details shall be disclosed.
